- 1. Under normal circumstances, your re-allocation instruction made on this mandate form will be processed within 5 business days\* from the date the Trustee receives this form. At the same time, if you have selected our LifeEasy service, the submission of this form will deem you to have elected to leave LifeEasy and the service will be disabled automatically.
